

## COOKIES POLICY (the “Policy”)

This cookies policy (“Cookies Policy”) contains information about our use of cookies. We will ask you to consent to our use of cookies in accordance with the terms of this Cookies Policy when you first visit our website (the “Site”).

In this Cookies Policy, we, us or ourselves means Trancura Legal Consulting Ltd, a company registered in the United Kingdom under number 11399507, whose registered offices are at 4<sup>th</sup> Floor, 18 St Cross Street, London, United Kingdom, EC1N 8UN.

### 1. Our use of cookies

1. A cookie is a file containing an identifier (a string of letters and numbers) that is sent by a web server to a web browser and is stored by the browser. The identifier is then sent back to the server each time the browser requests a page from the server.
2. Cookies may be either "persistent" cookies or "session" cookies: a persistent cookie will be stored by a web browser and will remain valid until its set expiry date, unless deleted by the user before the expiry date; a session cookie, on the other hand, will expire at the end of the user session, when the web browser is closed.
3. Cookies do not typically contain any information that personally identifies a user (except for IP addresses in some cases), but personal information that we store about you may be linked to the information stored in and obtained from cookies.
4. We use these kinds of cookies:
  - (a) **Strictly Necessary Cookies:** these cookies are essential to provide you with services available through our Site and to enable you to use some of its features. For example, they help the content of the pages you request load quickly. Without these cookies, the services that you have asked for cannot be provided, and we only use these cookies to provide you with those services.
  - (b) **Analytical/Performance Cookies:** these cookies are used to collect information about traffic to our Site and how users use our Site. It includes the number of visitors to our Site, the websites that referred them to our Site, the pages that they visited on our Site, what time of day they visited our Site, whether they have visited our Site before, and other similar information. We use this information to help operate our Site more efficiently, to gather broad demographic information and to monitor the level of activity on our Site.

- (c) **Google Analytics:** The Site use Google Analytics (an analytical/performance cookie) to help analyse how users use the Site, collecting standard internet log information and visitor behaviour information in an anonymised form from which no user is identifiable. This information is transmitted to Google and processed to compile statistical reports on activity on the Site. These reports allow us to optimise our user experience.   - (d) **Third Parties:** Third parties (including, for example, advertising networks and providers of external services like web traffic analysis services) may also use cookies, over which we have no control. These cookies are likely to be analytical/performance cookies or targeting cookies. Targeting cookies are cookies that remember sites that you visit and are used to deliver targeted advertising tailored to your interests.
5. Most browsers allow you to refuse to accept cookies and to delete cookies. The methods for doing so vary from browser to browser, and from version to version. You can obtain up-to-date information about blocking and deleting cookies via the support pages made available by your browser operator.

## 2. **Third Parties**

The Site may contain links to third party websites and refer to third party service providers and other entities. If you follow a link to any third party website or deal with any third party referred to on the Site, then they may have their own privacy and cookie policies, and we are not responsible for their use of any personal data which you may provide to them.

## 3. **Amendments**

We may update this Cookies Policy from time to time by publishing a new version on the Site. You should check occasionally to ensure you are happy with any changes to this Cookies Policy, although we may notify you of significant changes to this Cookies Policy using the contact details you have given us.
